The terms "Piccolina Adventures" and "Piccolina" refer to "Piccolina Adventures and Laura Frew".

Release: Piccolina Adventures and Laura Frew, its employees, affiliates, officers, directors, successors, representatives and assigns (collectively Piccolina Adventures and Laura Frew) does not own or operate any entity which provides, or is to provide, goods or services for your trip and any pre or post trip tour or arrangements made by Piccolina Adventures including, for example, lodging facilities, transportation companies, food service providers, equipment suppliers, daycare providers, etc. As a result, Piccolina Adventures and Laura Frew is not liable for any negligent or willful act or failure to act of any such third person, or of any other third party.

In addition, I acknowledge that I have voluntarily applied to participate in the trip designated on the reservation form (or on any trip to which I may subsequently transfer). I am voluntarily participating in this trip with the knowledge of the numerous risks and dangers involved including but not limited to: negligence in any manner on the part of Piccolina Adventures and Laura Frew including, without limitation, negligence in the conduct or arrangement of the trip, with regard to bicycle selection or maintenance, the use, installation or maintenance of any optional or add-on equipment such as pedals, computers, bar ends, etc., in the advertising of the trip, in the maintenance or operation of any van or other motor vehicle utilized to transport passengers, in the behavior of guides, etc; uneven terrain and roads, bad weather and negligent or willful operation of motor vehicles, other bicycles or pedestrian conduct, physical exertion for which I am not prepared; forces of nature; transportation failures whether by plane, train, auto, boat, canoe, kayak, bicycle, ski, horseback or other animal, by foot, or by any other conveyance; consumption of alcoholic beverages; risks associated with food or impure water; civil unrest; terrorism or the threat thereof; criminal activity; dangers associated with wild or other animals; breakdown or failure of bicycles or other equipment; high altitude; accident or illness without access to means of rapid evacuation or availability of medical supplies or services; the adequacy of medical attention once provided; epidemics or the threat thereof; stolen, lost, or misplaced luggage or property and theft or break-ins into vans, lodging rooms or elsewhere. I acknowledge that the enjoyment and excitement of adventure travel is derived in part from the inherent risks incurred by travel and activity beyond the accepted safety of life at home or work and that these inherent risks contribute to such enjoyment and excitement, being a reason for my participation. I HEREBY AGREE TO BE RESPONSIBLE FOR MY OWN WELFARE AND ACCEPT ANY AND ALL RISKS OF DELAY, UNANTICIPATED EVENTS, INCONVENIENCE, ILLNESS, INJURY, EMOTIONAL TRAUMA OR DEATH.

Therefore, as lawful consideration for being permitted to participate on such trip(s), I hereby RELEASE AND DISCHARGE FOREVER PICCOLINA ADVENTURES AND LAURA FREW, ITS AGENTS, CONTRACTORS AND PARTNERS FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM MY PARTICIPATION IN THE TRIP. I agree that this release shall be legally binding upon me personally, all members of my family and all minors traveling with me, my and their heirs, successors, assigns, and legal representatives, it being my intention fully to assume all the risks associated with this trip and to release Piccolina Adventures and Laura Frew, its agents, contractors and partners from any and all liability to the maximum extent permitted by law.

I hereby assign all right, title and interest I may have in or to any all media in which my name or likeness might be used.

Safety: Whether required by law in the destination country or not, I assume all responsibility for compliance with laws requiring helmets and agree to wear a helmet while on the tour. I agree to follow all written and verbal rules of safety presented to me by Piccolina Adventures and Laura Frew. Piccolina Adventures reserves the right to make route, hotel, itinerary and trip modifications as required or desirable to improve the trip quality and/or to accommodate the comfort and well-being of guests.
